JAMES K. ECK

James K. Eck is the Director of the Strategic Plans and Requirements Directorate, Headquarters Air Force Operational Test and Evaluation Center at Kirtland Air Force Base, N.M. He is responsible for test and acquisition policy, resource programming, strategic planning, and test requirements for AFOTEC's headquarters, detachments, and operating locations.

Prior to this assignment, Mr. Eck was a senior inspections specialist at the Air Force Inspection Agency where he served as the Division Chief in the Inspections Directorate. In this role, he led a division of inspectors that conducted management and unit effectiveness inspections of organizations across the Air Force.

Prior to his entry into the federal civilian service in 2014, Mr. Eck served more than 26 years in the Air Force and retired as a colonel in June 2014. He was a bomber navigator/weapon systems officer with more than 3,500 hours in the B-1 and B-52 aircraft. During his active duty career, he deployed in support of



Operations Desert Storm, Enduring Freedom, and Iraqi Freedom. He also had the privilege to command the B-1 Bomber Squadron at the U.S. Air Force Weapons School which was a selectively-manned flying squadron executing the Air Force's most advanced B-1 training program. Mr. Eck also had the opportunity to serve on the Air Staff at the Pentagon. He was the Navigator/Electronic Warfare Officer Career Field Manager where he managed the 4,700 person navigator/EWO force throughout their rated service in the Air Force. While in that role, Mr. Eck authored, championed, and briefed the Secretary of the Air Force on the navigator compensation proposal to improve retention which the SECAF approved in 2002. Additionally, Mr. Eck was in the Pentagon during the attacks on Sept. 11, 2001 and in the aftermath helped establish the Headquarters Air Force Crisis Action Team Combat Operations Watch Cell. He was later appointed the Chief of the Operations Watch Cell which kept Air Force senior leadership apprised of the current situation during the first several months of Operations Enduring Freedom and Noble Eagle.

Mr. Eck completed his active duty career as the Vice Commander of the Air Force Operational Test and Evaluation Center. He served in that position for three different commanders. Mr. Eck modified and overhauled organizational processes as necessary to meet the commander's leadership style and requirements. In his role as the Vice Commander, he was also dual-hatted as the AFOTEC Inspector General where he developed the AFOTEC Commander's Inspection Program to ensure compliance with the newly revised Air Force Inspection System.
