Roderick A. Earl is the Director of Safety and Environmental Management, Headquarters Air Force Operational Test and Evaluation Center, Kirtland Air Force Base, N.M. In this capacity, he is responsible for all aspects of safety, health, and environmental compliance for the Center's more than 76 major test programs at five detachments and 11 operating locations. He advises and represents the AFOTEC Commander on safety, occupational heath, and environmental concerns to the Office of the Secretary of Defense, Secretary of the Air Force Office of Acquisition, Air Force major commands, and other military service branches and federal agencies on operational test safety and environmental issues.

Mr. Earl was born in Orange, Calif., and raised as an Air Force family member traveling to various overseas locations with his family. He enlisted in the Air Force in 1985 and completed munitions systems technology training at Lowry AFB, Colo. He has served as a munitions controller at Clark AB, Republic of the Philippines; Senior Munitions Inspector and Operations Superintendent at McChord AFB, Wash.; Weapons Safety Officer and Nuclear Surety Officer at



Grand Forks AFB, N.D.; and Occupational Safety Superintendent at the 377<sup>th</sup> Air Base Wing, Kirtland AFB, N.M. His final two active duty Air Force assignments were as the Occuational Safety Manager at AFOTEC's Detachment 1 and as Chief of Occupational Safety at Headquarters AFOTEC, Kirtland AFB, N.M., where he specialized in chemical and biological safety and directed energy safety before retiring in 2005 from the Air Force.

He entered federal civilian service after military retirement and returned to AFOTEC as the Deputy Director of Safety before his current position as the Director of Safety and Environmental Management.
